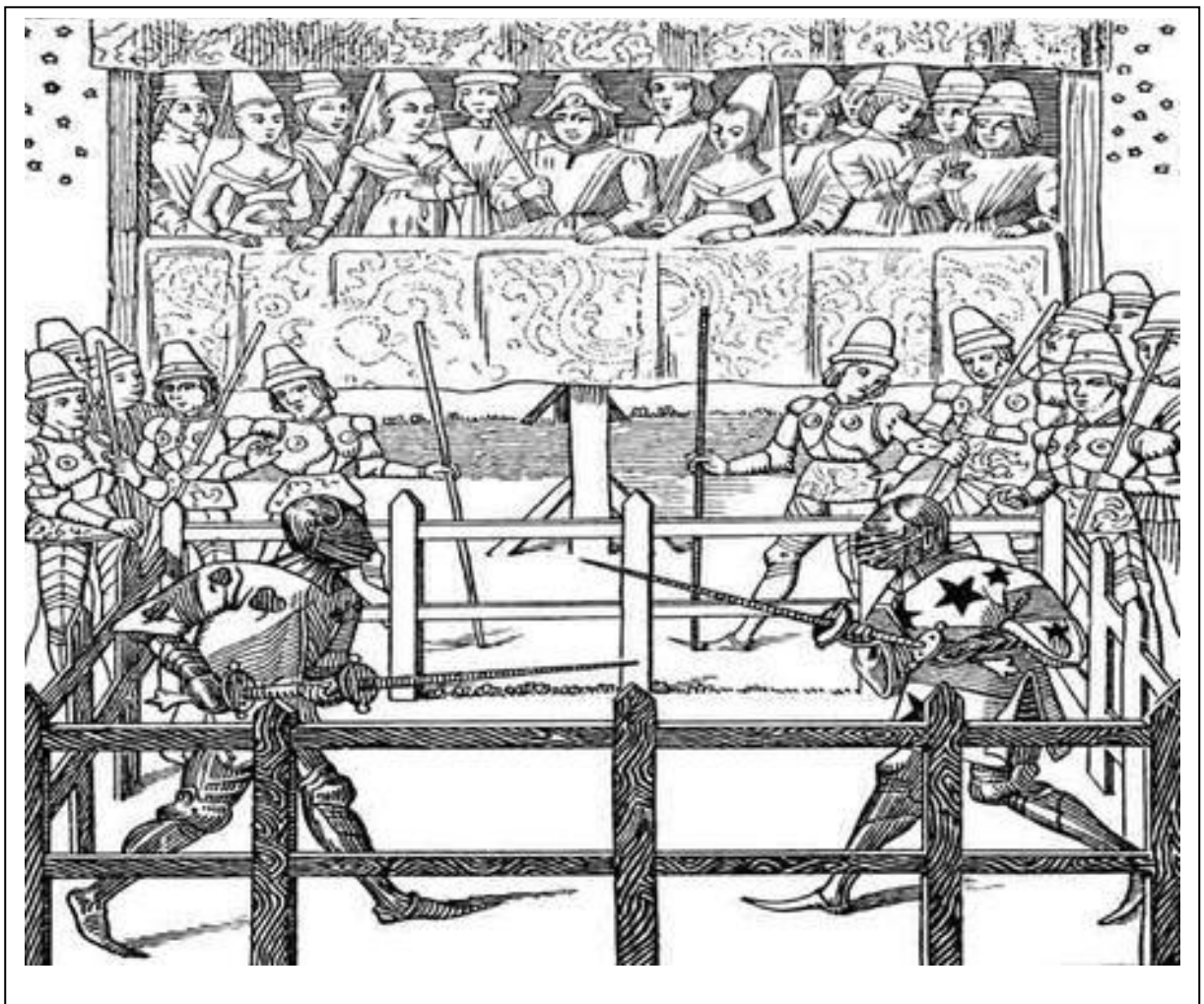

## **A Note from the Chronicler, Herr Gunther von Lindenwald:**

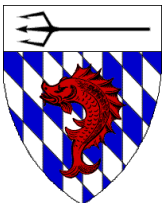

## Returns:

### 1: Balian of Buckston-on-Eno -New Device

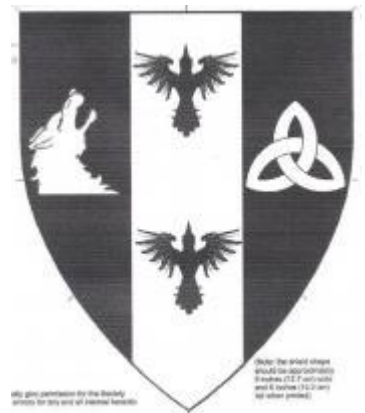
*Sable, on a pale, between a wolf's head ululant and triqueta argent, two crows migrant*

Consulting Herald: Tankred Bras-de-Fer, Opal and Gabriel the Traveler

Unfortunately, this device is in violation of SENA A.1.A.1, which states:

“Submissions that are documented under the Core Style rules are allowed to have a single *step from period practice*, sometimes denoted as SFPP. In older rulings this same concept was described as a *weirdness*. A step from period practice is an element not found in period, core style armory that we nonetheless allow. Some types of elements which are designated as a step from period practice are mentioned in the style rules. In addition, a partial list of elements that are a step from period practice is found in Appendix F. Any armorial submissions with more than one step from period practice will not be registered under the Core Style rules.”

As the ululant posture and the use of any non-eagle bird in the displayed posture are each considered to be Steps from Period Practice, and precedent tells us that “The migrant posture is considered equivalent to displayed”(Hlifa Hrafnisdóttir, August 2017 LoAR, A-East), this device must be returned.



## 2: Gabriel James West -New Badge

*(Fieldless) On a flame proper, a rabbit courant argent*

Consulting Herald: Gabriel James West

Unfortunately, we must return this badge, as it is neither distinctly a flame charged with a rabbit, nor a flame with a rabbit overall. The rabbit is not entirely on the flame, as a tertiary charge should be, nor is it large enough to be considered overall. Per SENA Appendix I, section D.4, “An overall charge must have a significant portion on the field; a design with a charge that has only a little bit sticking over the edges of an underlying charge is known as "barely overall" and is not registerable.”



## 3: Ma 'arifah bint Rashid -New Name & New Device

*Purpure, on a fess between three triangles argent, a hanging balance purpure*

Consulting Herald: Seraphina Delphino Ragged Staff

This name must be returned for lack of documentation—while the byname was sufficiently documented, no documentation was provided for the given name either with the submission or during commentary.

As all armory must have a name under which to be registered, we must also return the device at this time.

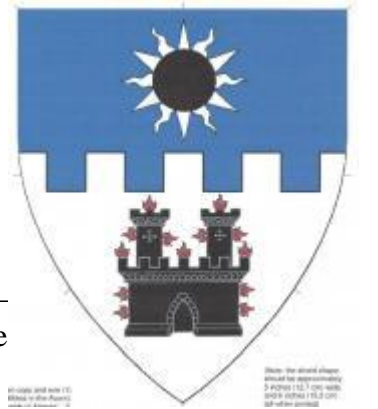


## 4: Rudiger der Burgunfaust -New Name & New Device

*Per fess embattled azure and argent, a sun argent eclipsed and a castle sable enflamed gules*

Consulting Herald: Dietrich Saphir zum Drache

Unfortunately, this name must be returned for insufficient documentation. The given name submitted does not match the form in the documentation—Rüdeger, and submitter does not allow changes of any sort, which would be required to change to the documented form. Additionally, no documentation was provided for the byname, nor were commenters able to find any documentation for it.



As all armory must have a name under which to be registered, we must also return the device at this time.

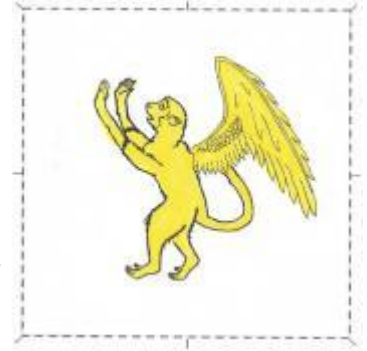
**5: Sara van Eerde -New Badge**

*Fieldless, a winged monkey salient Or*

Consulting Herald: Ragnarr Leifsson, Red Shark

This badge must be returned for conflict with the device of Olivia Alexandria registered in July of 2009 (via Gleann Abhann): *Vert, a monkey rampant winged and tailed of a dragon Or.*

While there is a DC for the field, the College of Arms does not grant difference between rampant and salient, nor for type of wing or tail.

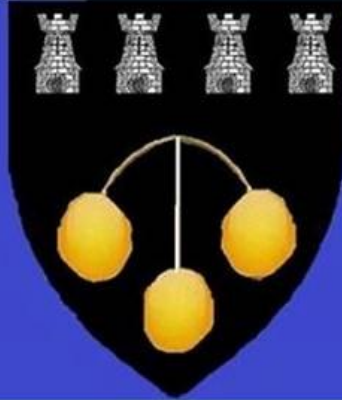

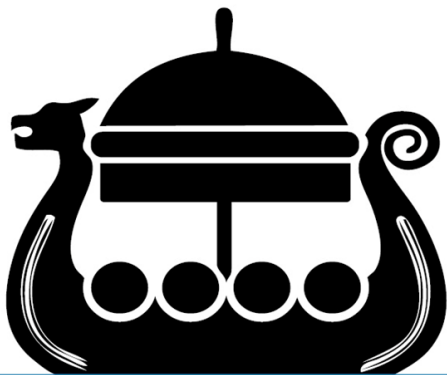
